- 8)Every person in charge of place should be display and exhibit a board stating that the place is a **"NO SMOKING AND NO SPLITTING PLACE AND THAT SMOKING IS AN OFFENCE"**
- 9)This certificate issued is liable to cancelled at any time on infringement if any of the above said conditions and for improper maintenance of sanitation, improper maintenance of the building as well toilets in the Establishment.
